Scott led meeting with introductions of board members

Points/Dates to remember:

- Registration for county closes the 18th – clinic closes March 1st
- 3/10/2007 is first coaches meeting –
- County games will be on Saturdays time frame of 9-1 Muth fields (times TBA after registration closes).
- April 28th is Soccer Family Fun Day – free soccer camp and Chick-Fil-A sponsored events - more info to follow
- March 18th – first game (for county)
- June 9th - Pizza Party

Rich Torres – Boys Director and Bill Neubrand – Girls Director:

- Discussed Evaluation process – to be held on 2/24/07 with rain date of 3/3/07 – explained that no recommendations will be taken (i.e. – this player wants to play with that player...) – Purpose is to get the kids to be playing where they best fit in order to be more competitive and build morale/confidence.
- Some coaches commented that this was good so that the divisions can be more competitive and expressed need for this to be communicated with parents/players ASAP to explain that team placement is not in coaches hands to choose players and that the BOD will be evaluating and placing players as appropriate. Letter will be drafted by Karen and Rich and will go out by the weeks end (to include uniform and evaluation info, as well as statement that if players do not come to evaluation they will not be placed).
- County games will be Sundays
- Discussed new uniforms - cost of \$45 includes 2 jerseys, a pair of shorts and 2 pairs of socks – will send out letter to parents/players regarding this information with explanation – old vendor no longer in business
- U14 are exempt and if whole team has old uniform they can continue to use these.

Glenn Shorter – County Commissioner

- County placement meeting will be held on March 21st (Glenn will be attending this as our rep)
- 1st game of the season will be 3/18 – season ends May 20th
- One make up games for spring will be June 3rd
- Schedules should be posted by 3/14/07
- No Games 4/8 (Easter)
- 3/13 – Coaches Certification Clinic 6:00 pm at Old Mill – all new coaches must attend by end of 1st year

Scott - Treasurer

- Registration – currently have approx 570 registered
- Registration closes March 1st for clinic and 18th for county
- Treasurer Report – currently have \$20,000 in CD; \$11,627.03 in checking ; and \$19,371.38 in savings - ended year on the plus side and will transfer approx \$5000 from last years budget into savings
- Beth will need help with uniform organization and distribution to be scheduled early March
- Discussed fee reimbursement for tournaments, which has gone up to \$400 per season as well as referee fees which as of now, have not increased
